ADVERTISEMENT NOTICE

Applications are invited from the eligible and interested candidates for the following posts to be filled on Deputation (ISTC) basis in Central Research Institute, Kasauli under Ministry of Health & Family Welfare. The posts are as under: -

1. One post of Deputy Assistant Director (Bio-Chemistry) (Non Medical), General Central Service, Group 'A' Gazetted (Non-Ministerial) in the Pay Level-10 (Rs.56100-177500).
2. One post of **Veterinary Officer**, General Central Service, Group 'A' Gazetted (Non-Ministerial) in the Pay Level-10 (Rs.56100-177500).
3. One post of **Assistant Library and Information Officer**, General Central services, Group 'B' Gazetted (Non-Ministerial) in the level-7 (44900-142400).
4. One post of **Assistant Engineer (Instrumentation)**, General Central Service, Group 'B' Gazetted (Non-Ministerial), posts in the Pay Level-7 (Rs.44900-142400) .

Note 2: The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation similarly deputationists shall not be eligible for consideration for appointment by promotion.

than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.
