Applications are invited for one post of Veterinary Officer, General Central Services Grc Gazetted (Non-Ministerial) in the Pay Level-10 (Rs.56100-177500) {Pay Band-3, Rs. 15600-39100 + Grc Rs.5400/- (Pre-revised)} in Central Research Institute, Kasauli Under Ministry of Health & Family Welfar post is required to be filled by deputation (including short term contract) from Officers of the Central Government or Union territory Administration or Public Sector Undertakings or Universities or Reco Research Institutions or Semi Government or Autonomous Bodies or Statutory Organizations as under.:
