ABRIDGED NOTICE

Applications are invited for one post of Assistant Director (Rajbasha), General Central Civil Service, Group 'A' Gazetted (Non-Ministerial) in the Pay Level-10 (Rs.56100-177500) in Central Research Institute, Kasauli Under Ministry of Health & Family Welfare. The post is required to be filled by deputation from amongst the Officers from the Central Government or State Government or Union territory Administration as under.:-

- (a) (i) Holding analogous posts on regular basis in the parent cadre or department; or
 - (ii) with three years' service in the grade rendered after appointment thereto on a regular basis in posts in pay Level-7 in the pay Matrix (Rs.44900 to142400); or
 - (iii) with eight years service in the grade rendered after appointment threto on a regular basis in posts in Level -6 in the pay matrix (Rs. 35400 to 112400); and
 - B) Possessing the following educational qualifications and experience.

Essential :-

Master degree of a recognised University in Hindi with English as a compulsory or elective subject or as the medium of examination at the degree level;

OR

Master degree of a recognised University in English with Hindi as a compulsory or elective subject or as the medium of examination at the degree level;

OR

Masters degree of a recognised University in any subject other than Hindi or English, with Hindi medium and English as a compulsory or elective subject or as the medium of examination at the degree level;

OR

Master degree of a recognised University in any subject other than Hindi or English, with English medium and Hindi as a compulsory or elective subject or as a medium of a examination at the degree level;

OR

Master degree of a recognised University in any subject other than Hindi or English, with Hindi and English as compulsory or elective subjects or either of the two as a medium of examination and the other as a compulsory or elective subject at the degree level;

(ii) three years experience of using or applying terminology (terminological work) in Hindi and translation work from English to Hindi or vice versa, preferably of technical or scientific literature under Central Government or State Government or autonomous body or statutory organisations or public sector undertakings or Universities or recognised research or educational institutions;

OR

Three years experience of teaching in Hindi or English or research in Hindi or English under Central Government or State Government or autonomous body or statutory organisations or public sector undertakings or Universities or recognised research or educational institutions;

Desirable:

Studied one of the languages other than Hindi included in the Eighth Schedule of the Constitution in 10th standard from a recognized Board.

- Note 1: The departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation,. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.
- Note 2. Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years.
- The maximum age-limit for appointment by deputation shall be 'not exceeding fifty six years' as on Note 3. the closing date of receipt of applications.
- Note 4: For the purposes of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 01.01.2006 or the date from which the revised pay structure based on the 6th Central Pay Commission shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.
- Note 5. The person selected will be entitled to draw pay deputation allowance in accordance with the Department of Personal & Training. OM No. 2/11/2017-Estt. (Pay-II) dated 24.11.2017 and as amended time to time.
- Note 6. The applications of suitable Officers who are willing and eligible for the post and who can be spared immediately in the event of selection may be forwarded, through proper channel, duly verified to the undersigned within 45 days of publication in Employment News, in the prescribed proforma, alongwith ACR dossiers for the last 5 years, Integrity Certificate, Vigilance Clearance and statement giving details of major or minor penalties imposed on the officer, if any, etc.

Note 7. The candidate once selected for the post will not be allowed to withdraw the candidature under any circumstance. Incomplete applications shall not be entertained.
