In reference to our Tender Notice No.II-4/Tender/19-20/St. for purchase of 4262 qtls. **Dry Grass** during the year 2019-20 (item at serial No.2 of tender notice), the **specifications and important notes** at **page 2** of tender documents for the item may please be read as under:


Specifications and Important Notes:

- 1 Dry grass should be from the latest harvest.
- 2 It should be edible & of good quality.
- 3 It should be cut after the flowering but before going to seed.
- 4 *Moisture Content should be less than 16 percent.*
- 5 *Fiber content should be not be more than 16 percent.*
- 6 *Total digestive nutrients (TDN) should not be more than 66 percent.*
- 7 The colour should be greenish
- 8 It should be with pleasant smelling and leafy.
- 9 It should not be burnt.
- 10 It should not be mouldy or with fungus development.
- 11 It should not be weathered or discoloured,
- 12 It should be free from dirt, foreign material like pine needles, sticks, leaves of trees, weeds, pieces of wire, wood, nuts, stones and waste metal etc. The decision on quality to be assessed by Raw Material Inspection team comprising of Officer-in-Charge of Animal Facility, Quality Control Division and Stores Section or senior-most officer/official nominated by O i/c. Their decision shall be final and shall be abided by all concerned.

Schedule of supply:

1. Dry grass will have to supplied throughout the year. The supply of Dry Grass should be sufficient for next 15 days minimum and repeat supply to be made after 14 days. In case 14th day being holiday then supplies to be repeated on 13th from earlier supply.
2. The contractor shall be responsible for making all necessary arrangements for deliveries of the ordered quantities of Dry Grass at Drumbar Stables and New Animal House of CRI Kasauli in accordance with our supply orders.
3. In case of any shortfall in the supply of this item observed during a period of seven days, the Director of this institute holds the right to purchase this item from elsewhere without any notice to the contractor. The extra expenditure incurred by this institute on this account, if any, shall be chargeable to the contractor concerned.

Note : Quantity ordered may vary in accordance to animal strength in the institute.
